Business and Association Voting

A business may vote only once and must vote by designating a representative who can be either a member or non-member. Examples of such businesses are:

- Incorporated entities (i.e. Inc., Ltd.)
- Incorporated associations
- Incorporated societies (i.e. Incorporated under the Society Act of BC)

Unincorporated associations must designate a representative who is a **member**. This is an exception to the one member, one vote rule as per the Credit Union Incorporation Act, Section 70.4.

Businesses and unincorporated associations must register to vote by May 8, 2023.

To designate a representative, a Designation of Voter form must be completed and submitted to the credit union by May 8, 2023, via email to strongertogether@npscu.ca or dropped off at any NPSCU branch. Once the information provided has been verified, a a follow up call, no later than May 5, 2023, will be made directly to the Designated Voter to provide voting credentials.
